

*\*This code is in effect from the 16<sup>th</sup> day of July, 2021 until October 11, 2021. Please read this Code of Conduct and ensure you and your registered family members agree to abide by the regulations set forth below\**

Grangeways Inc. welcomes you! Please read this Code of Conduct (the Code) and review it with all family members. The rules in this Code must be followed to ensure we all stay safe and do not engage in activities that contravene any Provincial or Federal Government regulations and ensure we comply with all health regulations. It is important to remember that, ultimately, we are all in charge of our own health and safety. Please remember to bring a mask and gloves or hand sanitizer for the occasion that you will need it.

This Code is over and above our normal campground rules, which still apply. Strict enforcement of all rules will be in place for all people on your camping permit, or registered visitors to your site. **Any camper or visitor, regardless of age who breaches this Code will be asked to leave the campground immediately and your reservation will be cancelled immediately with no refunds.**

**If you have a fever or flu-type symptoms, please stay home.** If you have tested positive for COVID-19, are a presumptive case, or have been in contact with anyone who has tested positive or is a presumptive case, we request that you do not attempt to enter the campground. Please remain at your residence until you have been cleared by your local health department and/or you have finished your self-isolation of 14 days.

**If you are returning from travel from outside of the Province of Ontario, do not plan to visit the campground for a period of 14 days, please remain home.**

### Operation for the 2021 Season during COVID-19

At all times campers must obey social distancing rules as mandated by the Province of Ontario. Currently, you must stay 2 meters or 6 feet away from other campers to prevent the spread of COVID.

### Social Gatherings

- Outside social gatherings – 100 people
- Indoor social gatherings – 25 people

### Visitors

- Must be pre-registered at least 24 hours in advance of their visit. Those who are not pre-registered will be denied entry. Those found un-registered on property will be asked to leave immediately and the registered camper will be held responsible.
- Must read and agree to abide by COVID-19 regulations and Code of Conduct, in addition to regular campground rules.
- Visitors must pass COVID-19 screening questions prior to entering the property.
- RESTRICTIONS: Overnight guests are only permitted to transient campers if they are family members\*
- Grangeways Inc. has the right to limit the number of visitors to a site at any given time.

### Recreational Facilities & Common Areas

- **OPEN** – rentals available for ping pong, mini putt, shuffleboard and horseshoes.
- If equipment is returned damaged, site occupant will be held responsible for the charge.

### **Children and/or under the age of 16**

- We expect that all parents will ensure their children will be under their direct supervision and obey the rules 24/7. If your children cannot follow these rules, please do not bring them to the campground at this time.

### **Pool**

- **OPEN** - with occupancy limits advised by Health Department.
- ALL SWIMMERS MUST SIGN-IN WITH STAFF prior to use and adhere to social distancing guidelines.
- 15 min time slots will be enforced if the pool is busy.
- Please use squares provided for personal belongings.

### **Office/Store**

- **OPEN:** Sunday – Wednesday 10am-6pm, Thursday – Saturday 10am-8pm
- Must wear a mask, one person limit in the office at a time.

### **LAUNDRY ROOM**

- **OPEN:** Masks must be worn, social distancing, limited number of people at a time.

### **ICE CREAM**

- **OPEN** - during specified hours: Friday 7-9pm, Saturday 2-4pm & 7-9pm, Sunday 12-3pm.
- Masks must be worn when ordering, social distancing while in line.

### **Events/Activities**

- Scheduled outdoor & indoor activities as permitted by gathering restrictions.

### **Outdoor Staff**

Please do not stop outside staff for maintenance requests. If you have requests please email the office and we will deal with them accordingly when able to do so.
